



## RESOLUTION NO. 2363

### A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF WICKENBURG, MARICOPA AND YAVAPAI COUNTIES, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON NOVEMBER 5, 2024

**WHEREAS**, the Town of Wickenburg, Maricopa and Yavapai Counties, Arizona did hold a general election on November 5, 2024, for the nomination of Mayor and three (3) Councilmembers; and

**WHEREAS**, the election returns have been presented to and have been canvassed by the Town Council and attached as Exhibit "A."


